Some of the comments and suggestions from parents are ...

• We would like hot lunches to be provided by the nursery

Action: This is something that we have looked into in great detail before. Unfortunately, we do not have the space to put in a commercial kitchen to allow hot food to be prepared on nursery premises. We are governed by Environmental Health guidelines with regards to reheating foods, full details of which can be found in our Healthy Eating and Packed Lunch policy. We try to ensure that children are involved in a variety of cooking experiences and that on one morning and one afternoon per week our children have the opportunity to have a healthy hot snack.

• We would like more regular posts on the facebook page

Action: We hope that you have noticed that we are adding to our Facebook page on a more regular basis, showing the wide variety of experiences going on in all three of our playrooms. This is an area we will continue to monitor to ensure that we use this platform effectively.

• I am not confident that the staff have the qualifications to care for my child and the skills to support their learning and development

Action: Both Nursery Owners have teaching degrees and our Depute Manager holds the BA Childhood Practice degree. Early Years Practitioners hold either HNC or SVQ3 childcare qualification and our nursery assistants are working towards their SVQ3 qualifications. We will add these details to our staff board so that it is clear what qualifications our staff hold. Staff are closely monitored by our management team to ensure that each children's individual needs are being met. We ensure that we meet our child:adult ratio requirements at all times throughout the nursery day.

• I am concerned by the high staff turnover recently

Action: We acknowledge that, in the past 6 months, we have been in the unfortunate position of losing four members of staff. Prior to this, however, our staffing remained static for 2 years. The nursery has always been committed to developing a professional and dedicated staff team, and we take pride in the fact that since opening seven years ago, staff have only left us for promotions, career changes or for personal reasons. Please be reassured that we always try to maintain a very strong staff team and that our recruitment of new staff is rigorous with the needs of the children and the nursery at the heart of this process.
